### Classes

If entries warrant, classes will be divided into Open/Junior/Adult Amateur/School Horse divisions. Ribbons to 5<sup>th</sup> place. You may enter 2 consecutive levels, a maximum of 4 technical tests plus equitation.

**WELCOME TO NEWCOMERS** Classes 1 (a) and 1 (b) – for riders who are in their first or second year of dressage competition including events and schooling shows. You may enter these classes at all shows, green or more experienced horses or ponies may be used. 20 X 40 m ring

CLASS 1(a): Dressage Canada 2010 Walk/Trot Test C
CLASS 1(b): Dressage Canada 2010 Walk/Trot Test D

**INTRODUCTORY DRESSAGE** Classes 2 (a) and 2 (b) – for horses in their first or second year of dressage competition only, including events and schooling shows. Green or more experienced riders may enter. 20 X 40 m ring

CLASS 2(a): Dressage Canada 2010 Walk/Trot Test A CLASS 2(b): Dressage Canada 2010 Walk/Trot Test B

**CLASS 3: DRESSAGE EQUITATION – W/T** – Riders in this class may not enter any canter classes.

**CLASS 4: DRESSAGE EQUITATION – W/T/C –** Riders judged in groups of 6 or less.

CLASS 5: USEF 2015 Training Level Test 2 20 X 60m
CLASS 6: USEF 2015 Training Level Test 3 20 X 60m

CLASS 7: USEF 2015 First Level Test 2 20 X 60m
CLASS 8: USEF 2015 First Level Test 3 20 X 60m

CLASS 9: Walk/Trot Leadline Test – For beginner riders 12 and under as of January 1, 2015

Entries are due the Monday before the show date on August 17<sup>th</sup> by 9 pm. Late entries will only be accepted if there is room. The show will be capped at 20 entries.

### Entry Information

- Classes 1(a) to Class 8 \$25.00 per class, HST included. Admin/Medic Fee of \$15/rider also applies.
- Class 9 (Leadline) special entry fee of \$10.00, HST included. (The horse or pony used for the leadline mount must already be entered in at least one other class at this show.)
- All competitors and horse owners must be members of the Ontario Equestrian Federation (OEF).
- Entries with payment must be in the hands of the Show Secretary by 9 PM Monday August 17<sup>th</sup>. This must include a copy of the 2015 OEF membership for rider and owner (if different).
- A small canteen will be available on the show grounds.
- Late entries will be accepted if there is room. Phone or email entries will be accepted with electronic fee transfer only.
- Riding times will be emailed to competitors on the Thursday before the show. They will also be posted under the Events section of the website <a href="https://www.skylinefarmcommunity.com">www.skylinefarmcommunity.com</a>.
- Tack to be in accordance with EC rules. Horses may wear boots/bandages; whips may be carried.
- SkyLine Farm is located 2 miles northwest of the village of Dunrobin. At the stoplight in Dunrobin, turn west onto Thomas Dolan Parkway and go over the railroad tracks about 1 mile to Woodkilton Rd. Turn right (north) and go about 1 mile to 3133 Woodkilton Rd. We are on the left (west side of the road) with a big grey arena out front.

**REFUNDS** – If an entry is withdrawn before Thursday August 21, a \$20 handling fee will be retained. After this date there will be no refunds unless the space can be filled from the waiting list.

**OADG YEAR END AWARDS** – Please see the OADG website for full information and eligibility criteria for OADG awards as well as further details on the Ontario ESD Schooling Show Circuit.

**ADULT AMATEUR DIVISION** – AA is open to Senior Riders who do not teach riders or train horses or give clinics or seminars for re-numeration, do not act as an agent for the purchase/sale or lease of horses, are not Juniors, are not CET Short or Long Listed riders, are not current or former CET members, have not represented Canada internationally. Please see Equine Canada, Section E Dressage, Rule 3.4.2 Amateur for a full list of those NOT considered Amateurs for Dressage competition.

**JUNIOR DIVISION** – Open to all competitors who have not reached their 18<sup>th</sup> birthday as of 1 January, 2015.

**SCHOOL HORSE DIVISION** – Open to Junior Riders competing on a non-owned horse that is known to be school horse and is regularly part of an established lesson program. This division has been defined by *SkyLine* Farm for the purpose of awarding prizes for high point scores at this show for walk/trot entries only.
